## Description of first aid measures

Eye Contact	<ul style="list-style-type: none"> <li>▶ If product comes in contact with eyes remove the patient from gas source or contaminated area.</li> <li>▶ Take the patient to the nearest eye wash, shower or other source of clean water.</li> <li>▶ Open the eyelid(s) wide to allow the material to evaporate.</li> <li>▶ Gently rinse the affected eye(s) with clean, cool water for at least 15 minutes. Have the patient lie or sit down and tilt the head back. Hold the eyelid(s) open and pour water slowly over the eyeball(s) at the inner corners, letting the water run out of the outer corners.</li> <li>▶ The patient may be in great pain and wish to keep the eyes closed. <b>Inhalation</b>	<ul style="list-style-type: none"> <li>▶ Following exposure to gas, remove the patient from the gas source or contaminated area.</li> <li>▶ NOTE: Personal Protective Equipment (PPE), including positive pressure self-contained breathing apparatus may be required to assure the safety of the rescuer.</li> <li>▶ Prostheses such as false teeth, which may block the airway, should be removed, where possible, prior to initiating first aid procedures.</li> <li>▶ If the patient is not breathing spontaneously, administer rescue breathing.</li> <li>▶ If the patient does not have a pulse, administer CPR.</li> <li>▶ If medical oxygen and appropriately trained personnel are available, administer 100% oxygen.</li> <li>▶ Summon an emergency ambulance. If an ambulance is not available, contact a physician, hospital, or Poison Control Centre for further instruction.</li> <li>▶ Keep the patient warm, comfortable and at rest while awaiting medical care.</li> <li>▶ <b>MONITOR THE BREATHING AND PULSE, CONTINUOUSLY.</b></li> <li>▶ Administer rescue breathing (preferably with a demand-valve resuscitator, bag-valve mask-device, or pocket mask as trained) or CPR if necessary.</li> </ul>

**Indication of any immediate medical attention and special treatment needed**

for intoxication due to Freons/ Halons;

**A: Emergency and Supportive Measures**

- ▶ Maintain an open airway and assist ventilation if necessary
- ▶ Treat coma and arrhythmias if they occur. Avoid (adrenaline) epinephrine or other sympathomimetic amines that may precipitate ventricular arrhythmias. Tachyarrhythmias caused by increased myocardial sensitisation may be treated with propranolol, 1-2 mg IV or esmolol 25-100 microgm/kg/min IV.
- ▶ Monitor the ECG for 4-6 hours

**B: Specific drugs and antidotes:**

- ▶ There is no specific antidote

**C: Decontamination**

- ▶ Inhalation; remove victim from exposure, and give supplemental oxygen if available.
- ▶ Ingestion; (a) Prehospital: Administer activated charcoal, if available. **DO NOT** induce vomiting because of rapid absorption and the risk of abrupt onset CNS depression. (b) Hospital: Administer activated charcoal, although the efficacy of charcoal is unknown. Perform gastric lavage only if the ingestion was very large and recent (less than 30 minutes)

**D: Enhanced elimination:**

- ▶ There is no documented efficacy for diuresis, haemodialysis, haemoperfusion, or repeat-dose charcoal.

**POISONING and DRUG OVERDOSE, Californian Poison Control System Ed. Kent R Olson; 3rd Edition**

- ▶ Do not administer sympathomimetic drugs unless absolutely necessary as material may increase myocardial irritability.
- ▶ No specific antidote.
- ▶ Because rapid absorption may occur through lungs if aspirated and cause systematic effects, the decision of whether to induce vomiting or not should be made by an attending physician.
- ▶ If lavage is performed, suggest endotracheal and/or esophageal control.
- ▶ Danger from lung aspiration must be weighed against toxicity when considering emptying the stomach.
- ▶ Treatment based on judgment of the physician in response to reactions of the patient

**For frost-bite caused by liquefied petroleum gas:**

- ▶ If part has not thawed, place in warm water bath (41-46 C) for 15-20 minutes, until the skin turns pink or red.
- ▶ Analgesia may be necessary while thawing.
- ▶ If there has been a massive exposure, the general body temperature must be depressed, and the patient must be immediately rewarmed by whole-body immersion, in a bath at the above temperature.
- ▶ Shock may occur during rewarming.
- ▶ Administer tetanus toxoid booster after hospitalization.
- ▶ Prophylactic antibiotics may be useful.
- ▶ The patient may require anticoagulants and oxygen.

For gas exposures:

**BASIC TREATMENT**

- ▶ Establish a patent airway with suction where necessary.
- ▶ Watch for signs of respiratory insufficiency and assist ventilation as necessary.
- ▶ Administer oxygen by non-rebreather mask at 10 to 15 l/min.
- ▶ Monitor and treat, where necessary, for pulmonary oedema .

EMERGENCY CARE FOR HAZARDOUS MATERIALS EXPOSURE: 2nd Ed. 1994

As in all cases of suspected poisoning, follow the ABCDEs of emergency medicine (airway, breathing, circulation, disability, exposure), then the ABCDEs of toxicology (antidotes, basics, change absorption, change distribution, change elimination).

For poisons (where specific treatment regime is absent):

### BASIC TREATMENT

- ▶ Establish a patent airway with suction where necessary.
- ▶ Watch for signs of respiratory insufficiency and assist ventilation as necessary.
- ▶ Administer oxygen by non-rebreather mask at 10 to 15 L/min.
- ▶ Monitor and treat, where necessary, for pulmonary oedema.
- ▶ Monitor and treat, where necessary, for shock.
- ▶ Anticipate seizures.
- ▶ **DO NOT** use emetics. Where ingestion is suspected rinse mouth and give up to 200 ml water (5 ml/kg recommended) for dilution where patient is able to swallow, has a strong gag reflex and does not drool.

### ADVANCED TREATMENT

- ▶ Consider orotracheal or nasotracheal intubation for airway control in unconscious patient or where respiratory arrest has occurred.
- ▶ Positive-pressure ventilation using a bag-valve mask might be of use.
- ▶ Monitor and treat, where necessary, for arrhythmias.
- ▶ Start an IV D5W TKO. If signs of hypovolaemia are present use lactated Ringers solution. Fluid overload might create complications.

<b>Fire Fighting</b>	<p>-----</p> <p><b>GENERAL</b></p> <p>-----</p> <ul style="list-style-type: none"> <li>▶ Alert Fire Brigade and tell them location and nature of hazard.</li> <li>▶ Wear full body protective clothing with breathing apparatus.</li> <li>▶ Fight fire from a safe distance, with adequate cover.</li> <li>▶ If safe, switch off electrical equipment until vapour fire hazard removed.</li> <li>▶ Use water delivered as a fine spray to control fire and cool adjacent area.</li> <li>▶ <b>DO NOT approach cylinders suspected to be hot.</b></li> <li>▶ Cool fire exposed cylinders with water spray from a protected location.</li> <li>▶ If safe to do so, remove cylinders from path of fire.</li> <li>▶ Equipment should be thoroughly decontaminated after use.</li> </ul> <p>-----</p> <p><b>FIRE FIGHTING PROCEDURES:</b></p> <p>-----</p> <ul style="list-style-type: none"> <li>▶ Excessive pressures may develop in a gas cylinder exposed in a fire; this may result in explosion.</li> <li>▶ Cylinders with pressure relief devices may release their contents as a result of fire and the released gas may constitute a further source of hazard for the fire-fighter.</li> <li>▶ Cylinders without pressure-relief valves have no provision for controlled release and are therefore more likely to explode if exposed to fire.</li> </ul> <p>-----</p> <p><b>FIRE FIGHTING REQUIREMENTS:</b></p> <p>-----</p> <ul style="list-style-type: none"> <li>▶ Positive pressure, self-contained breathing apparatus is required for fire-fighting of hazardous materials.</li> <li>▶ Full structural fire-fighting (bunker) gear is the minimum acceptable attire.</li> <li>▶ The need for proximity, entry and special protective clothing should be determined for each incident, by a competent fire-fighting safety professional.</li> </ul>
<b>Fire/Explosion Hazard</b>	<ul style="list-style-type: none"> <li>▶ Containers may explode when heated - Ruptured cylinders may rocket</li> <li>▶ May burn but does not ignite easily.</li> <li>▶ Fire exposed cylinders may vent contents through pressure relief devices thereby increasing vapour concentration..</li> <li>▶ Fire may produce irritating, poisonous or corrosive gases.</li> <li>▶ Runoff may create fire or explosion hazard.</li> <li>▶ May decompose explosively when heated or involved in fire.</li> <li>▶ Contact with gas may cause burns, severe injury and/ or frostbite.</li> <li>▶ <b>POISONOUS: MAY BE FATAL IF INHALED, SWALLOWED OR ABSORBED THROUGH SKIN</b></li> </ul>

Minor Spills	<ul style="list-style-type: none"> <li>▶ Avoid breathing vapour and any contact with liquid or gas. Protective equipment including respirator should be used.</li> <li>▶ <b>DO NOT enter confined spaces where gas may have accumulated.</b></li> <li>▶ Increase ventilation.</li> <li>▶ Clear area of personnel.</li> <li>▶ Stop leak only if safe to do so.</li> <li>▶ Remove leaking cylinders to safe place. Release pressure under safe controlled conditions by opening valve.</li> <li>▶ Do not exert excessive pressure on the valve; do not attempt to operate a damaged valve</li> <li>▶ Orientate cylinder so that the leak is gas, not liquid, to minimise rate of leakage</li> <li>▶ Keep area clear of personnel until gas has dispersed.</li> </ul>

Safe handling	<ul style="list-style-type: none"> <li>· Consider use in closed pressurised systems, fitted with temperature, pressure and safety relief valves which are vented for safe dispersal.</li> <li>· Use only properly specified equipment which is suitable for this product, its supply pressure and temperature</li> <li>· The tubing network design connecting gas cylinders to the delivery system should include appropriate pressure indicators and vacuum or suction lines.</li> <li>· Fully-welded types of pressure gauges, where the bourdon tube sensing element is welded to the gauge body, are recommended.</li> <li>· Before connecting gas cylinders, ensure manifold is mechanically secure and does not contain another gas. Before disconnecting gas cylinder, isolate supply line segment proximal to cylinder, remove trapped gas in supply line with aid of vacuum pump</li> <li>· When connecting or replacing cylinders take care to avoid airborne particulates violently ejected when system pressurises.</li> <li>· Consider the use of doubly-contained piping; diaphragm or bellows sealed, soft seat valves; backflow prevention devices; flash arrestors; and flow monitoring or limiting devices. ## Exposure controls

<b>Appropriate engineering controls</b>	<p>Engineering controls are used to remove a hazard or place a barrier between the worker and the hazard. Well-designed engineering controls can be highly effective in protecting workers and will typically be independent of worker interactions to provide this high level of protection. The basic types of engineering controls are:</p> <p>Process controls which involve changing the way a job activity or process is done to reduce the risk.</p> <p>Enclosure and/or isolation of emission source which keeps a selected hazard "physically" away from the worker and ventilation that strategically "adds" and "removes" air in the work environment. Ventilation can remove or dilute an air contaminant if designed properly. The design of a ventilation system must match the particular process and chemical or contaminant in use.</p> <p>Employers may need to use multiple types of controls to prevent employee overexposure.</p> <ul style="list-style-type: none"> <li>▶ Employees exposed to confirmed human carcinogens should be authorized to do so by the employer, and work in a regulated area.</li> <li>▶ Work should be undertaken in an isolated system such as a "glove-box" . Employees should wash their hands and arms upon completion of the assigned task and before engaging in other activities not associated with the isolated system.</li> <li>▶ Within regulated areas, the carcinogen should be stored in sealed containers, or enclosed in a closed system, including piping systems, with any sample ports or openings closed while the carcinogens are contained within.</li> <li>▶ Open-vessel systems are prohibited.</li> <li>▶ Each operation should be provided with continuous local exhaust ventilation so that air movement is always from ordinary work areas to the operation.</li> <li>▶ Exhaust air should not be discharged to regulated areas, non-regulated areas or the external environment unless decontaminated. Clean make-up air should be introduced in sufficient volume to maintain correct operation of the local exhaust system.</li> <li>▶ For maintenance and decontamination activities, authorized employees entering the area should be provided with and required to wear clean, impervious garments, including gloves, boots and continuous-air supplied hood. Prior to removing protective garments the employee should undergo decontamination and be required to shower upon removal of the garments and hood.</li> <li>▶ Except for outdoor systems, regulated areas should be maintained under negative pressure (with respect to non-regulated areas).</li> <li>▶ Local exhaust ventilation requires make-up air be supplied in equal volumes to replaced air.</li> <li>▶ Laboratory hoods must be designed and maintained so as to draw air inward at an average linear face velocity of 0.76 m/sec with a minimum of 0.64 m/sec. Design and construction of the fume hood requires that insertion of any portion of the employees body, other than hands and arms, be disallowed.</li> </ul>
<b>Personal protection</b>	
<b>Eye and face protection</b>	<ul style="list-style-type: none"> <li>▶ Chemical goggles.</li> <li>▶ Full face shield may be required for supplementary but never for primary protection of eyes.</li> <li>▶ Contact lenses may pose a special hazard; soft contact lenses may absorb and concentrate irritants. A written policy document, describing the wearing of lenses or restrictions on use, should be created for each workplace or task. This should include a review of lens absorption and adsorption for the class of chemicals in use and an account of injury experience. Medical and first-aid personnel should be trained in their removal and suitable equipment should be readily available. In the event of chemical exposure, begin eye irrigation immediately and remove contact lens as soon as practicable. Lens should be removed at the first signs of eye redness or irritation - lens should be removed in a clean environment only after workers have washed hands thoroughly. The contents of such impervious containers must be identified with suitable labels. For maintenance and decontamination activities, authorized employees entering the area should be provided with and required to wear clean, impervious garments, including gloves, boots and continuous-air supplied hood.</li> </ul>

Environmental Fate: Carbon dioxide in earth's atmosphere is considered a trace gas. There are seasonal fluctuations of atmospheric concentrations of carbon dioxide primarily due to CO<sub>2</sub> absorbed during seasonal plant growth. Due to human activities such as the combustion of fossil fuels and deforestation, the concentration of atmospheric carbon dioxide has increased by about 35% since preindustrial times. Carbon dissolved in the oceans is about 50 times greater than CO<sub>2</sub> found in the atmosphere. The oceans act as an enormous carbon sink, having "absorbed about one-third of all human-generated CO<sub>2</sub> emissions to date." Generally, gas solubility decreases as water temperature increases. Accordingly the ability of the oceans to absorb carbon dioxide from the atmosphere decreases as ocean temperatures rise. Carbon dioxide is soluble in water, where it spontaneously interconverts between CO<sub>2</sub> and H<sub>2</sub>CO<sub>3</sub> (carbonic acid). The relative concentrations of CO<sub>2</sub>, H<sub>2</sub>CO<sub>3</sub>, and the deprotonated forms HCO<sub>3</sub><sup>-</sup> (bicarbonate) and CO<sub>3</sub><sup>2-</sup> (carbonate) depend on the pH. In neutral or slightly alkaline water (pH > 6.5), bicarbonate predominates (>50%) becoming most prevalent (>95%) at the pH of seawater, while in very alkaline water (pH > 10.4) carbonate predominates (>50%). The bicarbonate and carbonate forms are very soluble, such that air-equilibrated ocean water (mildly alkaline with typical pH = 8.2 - 8.5) contains about 120 mg of bicarbonate per litre. Most of the CO<sub>2</sub> taken up by the ocean forms carbonic acid. Some is consumed in photosynthesis by organisms in the water, and a small proportion of that sinks and leaves the carbon cycle. There is considerable concern that as a result of increased CO<sub>2</sub> in the atmosphere the acidity of seawater has been increasing. This may adversely affect organisms living in the water, as with increasing acidity the availability of carbonates, necessary for forming shells, decreases.

Atmospheric Fate: Methylene chloride is a volatile liquid that tends to evaporate to the atmosphere from water and soil. The main degradation pathway for methylene chloride in air is via reactions with hydroxyl radicals the average atmospheric lifetime is estimated to be 130 days. Because this degradation pathway is relatively slow, methylene chloride may become widely dispersed but, is not likely to accumulate in the atmosphere. The small amount of methylene chloride which reaches the stratosphere, (about 1%), may undergo direct breakdown by sunlight; however, this is not expected to occur in the troposphere. Reactions of methylene chloride with ozone or other common atmospheric species, (e.g., oxygen atoms, chlorine atoms, and nitrate radicals), are not believed to contribute to its breakdown.

Terrestrial Fate: The substance will evaporate rapidly from moist soil and does not sorb strongly to soil or sediment. Methylene chloride is likely to be highly mobile in soil and is expected to leach to groundwater. Biological breakdown is dependent on soil type, substrate concentration, and if the chemical gains or loses electrons, (redox reactions). The substance has been reported to be degraded in both oxygenated and low oxygen soils and degradation appears to accelerate in the presence of elevated levels of organic carbon. Methylene chloride has a low tendency to absorb to soil; therefore, there is a potential for leaching to groundwater. The substance is expected to evaporate from dry/moist soil.

Aquatic Fate: Methylene chloride will evaporate rapidly from water, however, evaporation rates vary with rate of mixing, wind speed, temperature, and other factors. The substance slowly breaks down in neutral pH water, with an experimental half-life of 18 months @ 25 C. This reaction rate varies greatly with changes in temperature and pH it has been estimated that the same reaction in acidic solutions would take 700 years. Oxygenated and non-oxygenated biological breakdown may be important fate processes for methylene chloride in water. Methylene chloride has been observed to undergo degradation at a rapid rate in the presence of oxygen.

Ecotoxicity: Only a few valid acute toxicity data, and no results from long-term studies in marine species, are available for this substance. Available data in marine species do not indicate a marked difference in the sensitivity of marine and freshwater species to this substance. Methylene chloride is moderately toxic to the common mummichog, daggerblade grass shrimp, and fathead minnow. The substance has low toxicity to Daphnia magna water fleas. Methylene chloride is not expected to accumulate/concentrate in aquatic organisms.
