### SECTION 4: First aid measures

#### Description of first aid measures

<b>General information</b>	Remove affected person from source of contamination. Move affected person to fresh air and keep warm and at rest in a position comfortable for breathing. Get medical attention if any discomfort continues.

#### Most important symptoms and effects, both acute and delayed
