**SECTION 4: First aid measures****Description of first aid measures**

<b>General information</b>	Get medical attention immediately. Show this Safety Data Sheet to the medical personnel.
<b>Inhalation</b>	Remove affected person from source of contamination. Move affected person to fresh air and keep warm and at rest in a position comfortable for breathing. Maintain an open airway. Loosen tight clothing such as collar, tie or belt. When breathing is difficult, properly trained personnel may assist affected person by administering oxygen. Place unconscious person on their side in the recovery position and ensure breathing can take place.
<b>Ingestion</b>	Rinse mouth thoroughly with water. Give plenty of water to drink. Stop if the affected person feels sick as vomiting may be dangerous. ### Extinguishing media

### Special hazards arising from the substance or mixture

If aerosol cans are ruptured, care should be taken due to the rapid escape of the pressurised contents and propellant. Vapours may form explosive mixtures with air.

### Advice for firefighters

**Protective actions during firefighting** Avoid breathing fire gases or vapours. Evacuate area. Keep upwind to avoid inhalation of gases, vapours, fumes and smoke. Cool containers exposed to heat with water spray and remove them from the fire area if it can be done without risk. Cool containers exposed to flames with water until well after the fire is out. If a leak or spill has not ignited, use water spray to disperse vapours and protect men stopping the leak. Control run-off water by containing and keeping it out of sewers and watercourses. Under normal conditions of handling and storage, spillages from aerosol containers are unlikely. If aerosol cans are ruptured, care should be taken due to the rapid escape of the pressurised contents and propellant. Small Spillages: Wipe up with an absorbent cloth and dispose of waste safely. Large Spillages: If the product is soluble in water, dilute the spillage with water and mop it up. ### **Precautions for safe handling**

#### **Usage precautions**

#### Appropriate engineering controls

Provide adequate ventilation. Personal, workplace environment or biological monitoring may be required to determine the effectiveness of the ventilation or other control measures and/or the necessity to use respiratory protective equipment. Use process enclosures, local exhaust ventilation or other engineering controls as the primary means to minimise worker exposure.
